- Trade in, purchase and sell (including sell short) foreign exchange contracts, on margin or otherwise using the OANDA fxTrade platform; and
- Take such other actions in connection with the subject matter of this Certification as OANDA may require or request or such Authorized Representatives may deem necessary or desirable.

A single username and password will be provided to the Entity and shall be used solely by the Authorized Representatives.

Any notices, statements or demands upon the Entity by or from OANDA in connection with the Entity’s account(s) may be delivered by e-mail, verbally or in writing to any of the Authorized Representatives or to any other apparently authorized persons on behalf of the Entity.

The execution and delivery of the OANDA Customer Account Application (including all applicable addenda thereto) and the OANDA Customer Agreement (including all Annexes and applicable addenda), as the same may be amended from time to time and all ancillary and other documents that may from time to time be required or requested by OANDA are hereby authorized. Any Authorized Representative may execute such Agreements, documents and all amendments thereto by and on behalf of the Entity and deliver the same to OANDA.

It is the intention of the Entity to give the Authorized Representatives the broadest possible power with respect to the Entity's account(s) and the Entity shall hold OANDA harmless against any and all liabilities, claims, losses, damages, expenses and attorney's fees that may arise directly or indirectly by reason of following any instruction, order, or direction given by any Authorized Representative or apparently authorized persons.
